Last year, Bulk Terminals Riga was a resounding success and the first time we have all been able to meet in person since 2019 in Amsterdam. Delegates from ABTO members SILOPOR suggested that the Bulk Terminals conference should be held in their port city of Lisbon this year. Other delegates in Riga enthusiastically agreed.

This year the Port of Lisbon is celebrating its 135th anniversary, so we are delighted that they will be our host port for Bulk Terminals 2023 – and very grateful for the support of the Port of Lisbon Authority, our local organisers for the conference.

Lisbon is ideally located along the world's major maritime trade routes, connecting the Mediterranean region with Northern and Central Europe – enabling trade with America, the Far East, Africa and Europe.

The port offers excellent conditions for the handling of all types of solid bulks. Agri-foodstuffs is a major segment, with a storage capacity of more than 420,000 tonnes, serving the oilseeds, edible oils and biodiesel markets. Clinker and cement trades are also served through a dedicated terminal with good river, road and rail access. The handling capacity for cargoes serving the steelmaking industry is over seven million tonnes a year.

With a full programme of presentations, panels and case studies the 2023 conference will start with the traditional analysis of bulk markets, continuing with a full programme focused on the concerns of operators – offering sound practical solutions to terminal operators for improving safety, streamlining operations and ensuring environmental protection.

Digitalisation, the cyber threat, development opportunities together and the ongoing impact of the continuing war in Ukraine on bulk terminal operations, will also be covered.

What will be the effect of the growing closeness between China and Russia on bulk trades? Bulk Terminals 2023 will examine the fallout regionally and internationally.

The Annual ABTO Bulk Terminals Conferences are designed for all those involved in the transportation, storage and handling of bulk commodities. As well as terminals and ports we welcome equipment and service suppliers, professional advisors and academics to the conference. Indeed, ABTO feels strongly it is only through the interaction with these others that bulk terminals will achieve increased operational efficiencies, together with safety and environmental compliance.

For delegates arriving on the evening before the conference the networking starts with ice breaker drinks in the bar of the Vila Galé Ópera Hotel.

After the proceedings at the end of the first day, the Port of Lisbon Authority are kindly hosting a reception at their headquarters near the mouth of the Tagus, the Gare Marítima de Alcântara. Built in 1943 and classified as a Monument of Public Interest, it was designed by Pardal Monteiro, one of the most important architects of the first half of the twentieth century in Portugal. The atrium of the second floor features magnificent fresco panels by the modernist Almada Negreiros. Bringing these two figures linked to contemporary Portuguese art together in the same work makes the Gare Marítima de Alcântara one of the most important modern constructions in Lisbon.

By popular request this year the Bulk Terminals conference will again include a terminal visit. We are delighted to be the guests of ABTO Members SILOPOR at their Trafaria Port Terminal. As well as the valuable networking opportunities afforded by the visit to the Trafaria Port Terminal, there will be a boat tour of Lisbon Port thanks to the generosity of the Port of Lisbon Authority, with lunch on board.

Conference Chairman Professor Mike Bradley and I together with the rest of the ABTO team, look forward to welcoming you to Bulk Terminals 2023 in Lisbon this October.

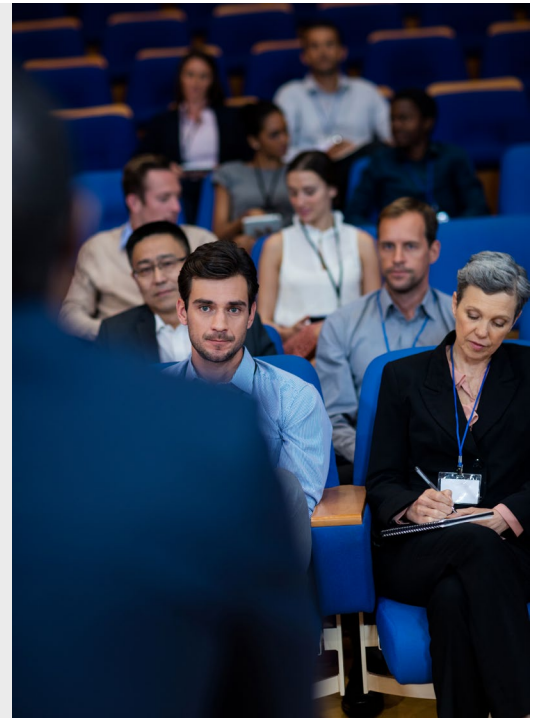

IMechE Compliance in Bulk Materials Handling 2023 – ABTO Supported Event

There are many industries which require the practice of bulk handling. A number of regulatory frameworks govern the handling of bulk solids, but there is a lack of formal training in this area and the amount of available information is quite limited.

This event aims to provide an overview of these issues to engineers from both end-users and equipment manufacturers. The seminar will provide a broad overview of the practical examples of common pitfalls. The event will cover procurement, design, operation, and maintenance stages in order to comply with regulation and foster best practice.

The seminar's agenda will focalise the complexities associated with materials selection in the design and manufacturing process of equipment as well as the difficulties associated with EU minimum safety requirements such as the ATEX directive or wider DSEAR user directive.

Located in the Tagus Estuary, the Port of Lisbon is a natural port, with a sheltered hydrographic basin of 32 thousand hectares. It is managed by APL - Administração do Porto de Lisboa, S.A. and is supported by an experienced port community.

It is today, as it has always been, one of the engines of development for the entire region and the country. It is one of the most important gateways for the trade that feeds the region and is a real launch pad for exports and economic growth. Inserted in the country's biggest economic and consumption center, the Lisbon and Tagus Valley (Vale do Tejo) region, the hinterland of the Port of Lisbon extends to the Iberian market, being one of the core ports of the Trans-European Transport Network (TEN-T).

The mission of the Port of Lisbon is clear: to provide a multifunctional client-oriented service and according to principles of operational and economic-financial rationality, social and environmental effectiveness and in accordance with best maritime and asset safety practices.

A Multifunctional Port

With regular shipping lines is the link between the Mediterranean and northern Europe and a hub for international trade between Europe, America and Africa.

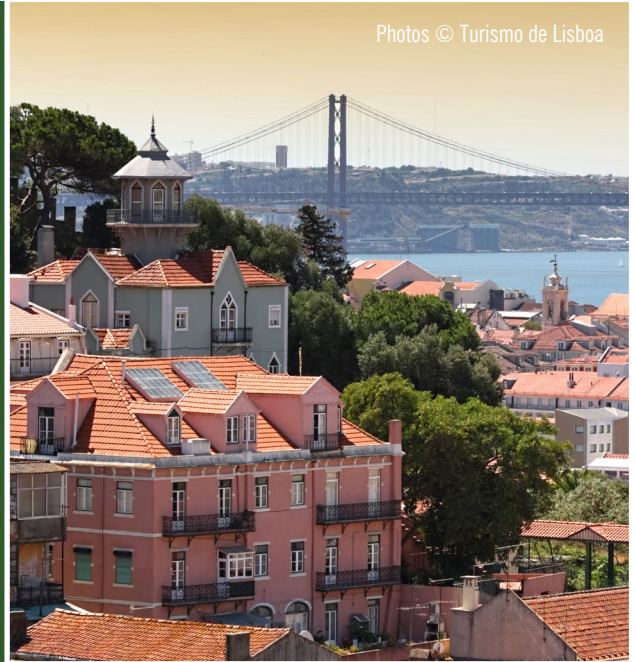

On the south bank, there are port terminals specialized in the handling of solid and liquid bulk cargoes.

The Port of Lisbon is furthermore the stage for ship repair, recreational boating, maritime-tourism and river passenger and cargo navigation activities.

The Port of Lisbon offers excellent conditions for the handling of all the type of solid bulks. Of particular note is the supply in the agri-food segment, where conditions are very competitive and there is an instantaneous storage capacity of over 420,000 tonnes.

Some of these terminals integrate industrial units of international relevance in the oleaginous, food oil and biodiesel markets. In this segment, the logistical conditions are equally excellent for the handling of clinker.
